The Community Foundation of Harford County (CFHC) is here to connect you to what matters in your community. ***At the Community Foundation, every donor is a true philanthropist, and every gift makes a difference.***

While your giving options are many, here at year-end we would like to highlight just a few:

- **DIRECT a Charitable Rollover from your IRA to CFHC to make a tax-free distribution.**
The one-year tax extenders package, including the IRA Charitable Rollover provision, has been approved.

The IRA Charitable Rollover extension EXPIRES on DECEMBER 31, 2014.

The extension allows people 70½ years or older to make direct transfers totaling up to \$100,000 per year to qualified charities without having to count the transfers as income for federal income tax purposes. IRA Charitable Rollover gifts count towards the minimum distributions required for people who have reached the age of 70½. Transfers must come from your IRA directly to a qualified charity, such as the Community Foundation of Harford County.

Donor-advised funds and supporting organizations are not eligible recipients of IRA Charitable Rollover gifts. Other funds at CFHC are eligible, including the CFHC Endowment for the Future, the Harford Community Fund, and more.

Because time is limited and gifts must be completed by December 31, 2014, anyone who would like to take advantage of the IRA Charitable Rollover should contact their financial advisor
