Another year has come and gone. The Women's Giving Circle has completed its eighth grant cycle, awarding \$54,715 to 16 organizations. Now, we turn our attention to the annual membership drive and we invite you to continue your legacy of local philanthropy through The Women's Giving Circle by renewing your membership. If you have already renewed for the 2019 grant cycle, THANK YOU!

Your annual tax deductible membership pledge of \$550 (allocated as follows: \$375 to the grant fund, \$125 to the endowed fund and \$50 for administrative expenses) directly impacts the lives of women and children in Harford County. It is because of our members that we have been able to award more than \$309,000 to local nonprofits since our inception in 2010. We need your help to continue our collective philanthropy.

Perhaps you qualify for the Next Generation membership? The Women's Giving Circle encourages young philanthropists to become members by offering a lower level of giving, for a limited time. A Next Generation member will pledge just \$350 annually for three years or until the age of 35, whichever comes first.
