



WILLIAM A. HUMBERT MEMORIAL SCHOLARSHIP

Thank you for your interest in applying to the Community Foundation of Harford County for an educational scholarship. All our scholarships are funded by generous donors who believe in the value of education.

Please carefully read the information below before submitting an application. Each specific scholarship includes its own qualifications and requirements. Applicants applying for multiple scholarships will need to include **ALL** required documentation for **EACH** scholarship.

GENERAL INSTRUCTIONS

1. **ALL applicants** must attend or have attended a high school in Harford County, MD
2. **ALL applicants** must be high school seniors (or college students where indicated) pursuing a degree at an accredited college or university
3. **ALL applicants** are required to submit the following documents:
 - a. a current high school transcript in pdf form (college transcript for current college students),
 - b. two letters of recommendation in pdf form, and
 - c. **ALL** additional required documentation as indicated below in pdf form
4. **ALL** applications and must be submitted at www.cfharfordcounty.org/scholarships
5. Applications with **ALL** required documentation must be submitted by midnight on **March 25, 2024**.

ELIGIBILITY:

William A. Humbert Memorial Scholarship is offered to a graduate of a Harford County high school who is currently a college junior or senior, or in a graduate program, and majoring in music or music education.

Below are the eligibility requirements for this scholarship:

- have attended a high school in Harford County, Maryland
- be a music or music education major in instrumental music.
- If awarded the Scholarship, awardee must perform at the Summer Concert Series held at the William A. Humbert Amphitheater in Bel Air, MD, in June 2020 at which time the scholarship will be formally presented. Performances will be with the Bel Air Community Band or Susquehanna Symphony Orchestra. Awardee performing with one of the ensembles must attend rehearsals(s) as requested by ensemble director.
- Previous Humbert Scholarship recipients, and students receiving full tuition scholarships, are not eligible for this award.

REQUIRED DOCUMENTATION:

Provide a single pdf document containing the following documentation:

1. Audio recording of representative repertoire performed by applicant and submitted as an mp3 file. Recording must be unedited. Recording should contain five (5) to fifteen (15) minutes of music performance. Any recording longer or shorter will not be accepted. At the beginning of the recording, announce the name of the performer and the title or the work(s) being

performed. Clearly label the mp3 file with the name of the performer, date of recording, and instrument. **IMPORTANT:** Due to technical limitations, this file cannot be uploaded onto the scholarship application. Students must email this mp3 file to info@cfharfordcounty.org.

2. Provide a single pdf document containing the following information:
 - a. Two letters of recommendation from applicant's ensemble director, private music instructor, and/or a person of choice.
 - b. A transcript of courses and grades through the most recently completed semester from applicant's current college/university.
 - c. A list of teachers of music (instrumental, private, piano, etc.) since entering college
 - d. List a representative sample.
 - e. An essay of 2,000 characters or less discussing your professional goals (elementary teaching, performance, etc.).
 - f. A list of activities and achievements in music, including high school (All County Band, All State Band, Orchestra, honors, awards, etc.). Limit 2,000 characters or less.

Incomplete applications, applications submitted without all the required documents, and applications received past the deadline date, will not receive consideration.
